7. Statement of Bank Passbook of the student (to be filled on A4 Size Paper, Account Number).
8. Statement of Bank Passbook of the student (to be filled on A4 Size Paper, 2022-23).
9. Aadhar Card (Photocopy)
10. Self declaration of the student to the competent authority.
11. Stamp of "Merit" will be stamped on the Merit certificate "Merit Merit" is filled in form (Student).
12. Stamp of "Merans" will be stamped on the Merans certificate "Merans Merans" is filled in form (Student).
