

1. INTRODUCTION

Babu Banarasi Das Northern India Institute of Technology, Lucknow has devoted itself to extend extensive opportunities for its faculties to pursue research and development activities.

The BBDNIIT's commitment to research in the area of science, engineering and technology has led to the development of centers of innovation and excellence. Every department is encouraged to have at least one such center.

BBDNIIT promotes the development of innovative products and processes. The aim of the policy is to provide the teachers of the institute the opportunity for sharing knowledge for academic growth and establish new collaborations to facilitate academic and research ambience in the institute.



2. RESEARCH POLICY

Faculty members are financially supported for presenting papers in conferences / attending Seminars, Workshop, FDP, SDP, delivering key note address/ invited talk and other similar events within India and abroad.

- Faculty members are allowed once in a year for national conference with registration fee.
- Faculty members are allowed once in a year for international conference within India with registration fee.
- Faculty members are allowed once in a year for international conference outside India with sponsorship from AICTE (Travel Grant) along with management sponsorship (subject to terms).
- Faculty members are allowed once in a year for attending seminar, workshop, FDP, SDP etc. with registration fee.
- The cost of train travel (AC-II/III) or bus fare for forward and return journey from the work place to the nearest railway station or venue of conference by shortest route would be reimbursed.
- In case of air travel, the difference of the air and train fares shall be borne by the faculty.
- Late fee, if any, shall be borne by the applicant.
- Faculty members can avail any two of the above-mentioned benefits in a financial year.
- The above stated events should be relevant to the area of specialization/ research of the applicant.

The faculty members pursuing PhD are facilitated with the following benefits.

 Members of staff pursuing PhD can avail 12 days On Duty leave per year for research work.



- Any fund raised or money earned by any faculty through grants, providing training and consultancy services etc., will be shared between the faculty members and the college at the ratio of 70:30 of the surplus.
- Any use of the College facilities like laboratories, lecture halls, workshops etc. are to be nominally charged and deducted from the fund.

3. NORMS FOR HONORARIUM OF PUBLISHED PAPER & PATENT

Papers Published /Indexed in following categories are eligible for Honorarium

For PUBLISHED PAPER

Category	Details	Honorarium
Category I	• Scopus	Rs.2000/-
Category II	 Science Cited Indexed (SCI) Science cited Indexed Expanded (SCIE) 	Rs.5000 /-

- Papers must be relevant to discipline.
- While claiming honorarium the published journal must be listed in their corresponding databases.

For PUBLISHED PATENT

- An honorarium of Rs. 10000/- or full registration fee (whichever is lower) is awarded by the institute.
- The patent must bear the name of this institute in full.
- Papers must be relevant to discipline.



4. ELIGIBILITY TO APPLY

- 1. All regular and full-time faculty members of the institute who have completed one year of services in the institute can apply.
- 2. The grant can be availed provided the faculty has a prior sanctioned leave for attending the program.
- 3. The applicant's proven record of research work, publications and the relevance of the event and its impact on the academic progression will be the important criteria for the sanction of the grant.
- 3. The sanctioned grant for attending the academic events will not be released in advance. The faculty will be required to claim the sanctioned grant after attending the event on the Conference Grant Claim Form along with the required documents (see Annexure).
