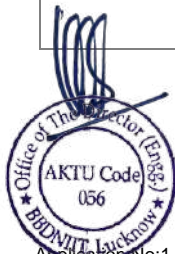

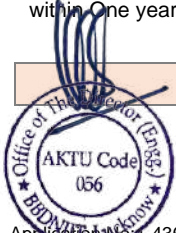

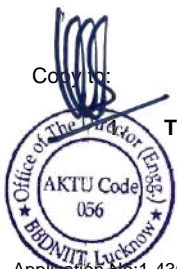
### Important Instructions
